The Harvest Trust is a charity that provides free holidays to groups of disadvantaged children who are between 8 and 11 years old. All of the week long holidays takes place between April and September at the Trust's own holiday home in Cardigan Bay, West Wales.

The Harvest Trust provides all the accommodation, transport and admissions free of charge. The only expense incurred by families/groups is food.

COUNCIL TAX

Council Tax Benefit is designed to help people who do not have enough money to pay their Council Tax bills.

There are also a number of schemes to help specific groups of people reduce their Council Tax bills. These include the Disability Reduction Scheme which reduces your Council Tax bill if someone in your household is disabled and you have a second bathroom or kitchen needed by that person. You also qualify for a reduction if you have a room in your house other than a bathroom, kitchen or toilet needed by a disabled person, or have enough space in your house for a wheelchair user who lives there.

THE ABOLITION OF THE MEANS TEST FOR PARENTS OF DISABLED CHILDREN

Back in April 2005 the Welsh Assembly Government decided to abolish the parental means test on housing adaptations for disabled children. Edwina Hart AM, Minister for Social Justice and Regeneration, announced on 30th September 2005 that the necessary legal regulations had now been introduced.
